1. MSCS Rule 19(1) and the relevant clauses of the Bye-laws of the SPG Multi-State Cooperative Credit Society Ltd. state that only members registered in the final voter list shall be eligible to vote in the said election.
2. The Provisional List of members will be available for inspection at the RO/ARO office, the registered office of the SPG Multi-State Cooperative Credit Society Ltd., all of its branch offices, and the Society's website.

3. A copy of the final voters list will be supplied to any member or delegate upon payment of the fee specified by the society's Board of Directors.
4. It is mandatory for the candidate, proposer, and seconder to be members of the SPG Multi-State Cooperative Credit Society Ltd., and their names must be included in the final voter list.
5. It is mandatory for the candidate, or a person authorized by them, or their nominee, to file a nomination form in the prescribed format—'Form III' for the Board of Directors and 'Form V' for Office Bearers—with the Returning Officer or Assistant Returning Officer within the prescribed time limit.
6. To be eligible to contest elections for the Board of Directors and as an Office Bearer, a candidate must fulfill the criteria under Sections 29, 43, and 44 of the Multi-State Cooperative Societies Act, Rules 19J, 19K, and 19L of the MSCS Rules, and the bye-laws of the SPG Multi-State Cooperative Credit Society Ltd.
7. An election deposit of Rs. 2,000/- (Rs. 500/- for Scheduled Castes and Scheduled Tribes candidates) is mandatory, and the receipt for this deposit must be attached to the nomination paper.
8. A candidate filing a nomination form under a reserved category (SC/ST/NT/OBC) must attach a self-attested copy of their caste certificate to the nomination form.
9. A candidate, their nominee, or their authorized representative (authorized in writing by the candidate) may give a written notice of withdrawal of candidature to the Returning Officer or Assistant Returning Officer within the prescribed time.
10. All contesting candidates must submit the details of their election expenses to the RO/ARO as per the provisions of MSCS Rules 19(U), (V), (W), and (X), and strictly adhere to the code of conduct.
